

Tortoise Global Water ESG Fund (TBLU)

3Q 2019 QUARTERLY COMMENTARY

The Tortoise Global Water ESG Fund uses a passive management approach and seeks to track the total return performance of the Tortoise Global Water ESG Index[®].

Tortoise provides research-driven indices that can be used as a realistic basis for exchange-traded products and thought leadership in the universe of essential assets. Its indices are intended to fill a void in the market and provide benchmarks and investable asset class universes for use by investment professionals, research analysts and industry executives to analyze relative performance as well as to provide a basis for passively managed exchange-traded products.

The Tortoise Global Water ESG Fund (TBLU) offers the purest exposure to the otherwise fragmented water industry. We believe that water is perhaps one of the most essential assets and is an area that requires continued investment in the years to come. This fund provides access to the water infrastructure, management and treatment companies that appear poised to benefit from the expected and much needed investment in rebuilding existing infrastructure, constructing new infrastructure and better managing this vital, but finite resource.

Water update

The water sector, as measured by the Tortoise Global Water ESG Index[®], returned 2.6% for the quarter. The Tortoise Global Water ESG Fund seeks to track this index. Both water infrastructure and water equipment and services sub-sectors contributed to positive returns.

The water infrastructure subsector led the way as the group advanced its positive performance from the first half of the year. The sector's positive performance was driven by its attractive, defensive growth as the group executes on a robust slate of infrastructure projects. The subsector continues to supplement its strong organic backlog with increased merger and acquisition activity as investor-owned utilities roll-up government-owned systems. The sector also benefitted from the regulated asset base, which generates predictable, stable cash flows, which is an attractive feature in the midst of a global economic slowdown. We believe the combination of organic and inorganic growth provide visibility into increased earnings and dividends over the long term.

The water equipment and services subsector also generated positive returns during the quarter as the subsector benefitted from the elevated spending from utilities and industrial users of water. Companies with residential and commercial offerings stood out among the group, as personal consumption remains resilient across the globe. We believe companies with leading technology offerings, including smart water networks, treatment, filtration

and test, are best positioned for future growth and profitability. We believe there is a long runway of growth as the sector continues to innovate and adopt technologies in pursuits of solving the global water crisis.

Going forward, the sector may face volatility as the global economic activity slows with weakening industrial activity as trade tensions persist. Over the long term, we believe the water sector remains well positioned to execute on a robust slate of infrastructure projects and technology offerings aimed at ensuring a safe and reliable water supply.
